### c) Renovation update - J. Fulton

- i. <u>Shape Architecture</u>: Work on the project is proceeding on schedule. Next week, SHAPE will be meeting with the District to discuss preliminary permits for the renovation. SHAPE has provided the Building Team with some drawings depicting their proposed building suggestions (new entrances, etc). The team is happy with what they have seen so far.
- ii. Storage shed: The shed was ordered today, and we can expect delivery in late March 2015.
- iii. Community/Neighbourhood Open House to be planned in partnership with SHAPE, likely late March or early April.
- iv. New chairs Our current collection of chairs takes up a disproportionate amount of valuable space, and are breaking down at a rapid rate. The Building Team will be purchasing new modular chairs (pictures and specs circulated), using Campaign funds. Cost estimated at \$3000.00
